AGENDA ITEM 5.1a



Hi!

I am excited to have the opportunity to come speak with you all next week. I am wanting to bring to attention a traffic/pedestrian safety issue that I experience daily in the downtown core.

There are many issues all surrounding this little area so I will try to break it down best I can.

There is a bus parking area on Patricia Street, in front of the Kiosks (The Jasper Adventure Centre), this parking area clearly states bus parking only.

I will systematically go through the issues.

Issue #1.

I have attached a photo of what I see majority of the time I am downtown or some

variation of this. One really problematic variation I see is cars parked in the bus zone and then the busses park in the first driving lane, sadly I haven't had the time to safely photograph this but I am sure you can picture what that looks like.

Why is this an issue? It is a bus zone, not a parking zone, people are breaking the bylaws. I have spoken with a bylaw personnel and this is an issue for them.

Furthermore, when cars are parked where busses are told to park they can't park there, so they then park in the driving lane. This is an issue obviously as well, a compounded issue. It disrupts the traffic flow and also makes it very challenging to access the little side street that leads to parking for the kiosks and other businesses located at that location.

This road is also the access point to and from the back alleys of businesses located on Patricia and Connaught Drive. It is a busy little street. It does't have a name anywhere that I can see which is why I have not called it by a proper name.

Issue #2

There is a cross walk at the top of that little side street and then there is another cross walk on Patricia immediately to the right.







Now picture where this small bus is parked, a tour bus, a big, tall tour bus, or even worse as mentioned in issue #1 cars parked in the bus parking and a bus parked in the first driving lane.

When this happens and you come up to the stop sign you cannot see oncoming traffic at all. Then you have to nudge in to the crosswalk disrupting pedestrians, and sneak out as best you can while also trying to turn right but right there is another crosswalk with other pedestrians. Before you know it you are effectively blocking pedestrians in two locations, likely cutting off someone in the driving lane and this is all the best case scenario IF you are a conscientious, careful driver who has some idea of the lay of the land in Jasper. If you are from out of town oh boy!!!

But I have a solution! I didn't want to come talk to you with just a problem but rather also armed with a solution. I look forward to further discussion and presenting my solution at the meeting.

The issue I would like to discuss is one that I reached out to each councillor about earlier this year in April.

I have continually brought this concept up with a variety of individuals in the community and have had very positive feed back about this concept. I will continue to reach out as I am very interested and committed to making this little dream a reality for my community.

April 22, 2023

Dear Councillor,

I am writing today to propose the idea of an indoor track in Jasper. My preliminary thoughts are to build an elevated track around the arena or use the Gymnastics Club space though you may know of other spaces that could work for this structure.

An indoor track would benefit every demographic in our town, especially our seniors. In winter, cold and ice are a debilitating factor and in summer, wildlife encounter and as of recent, air quality due to forest fires, can inhibit outdoor pursuits. People of all ages and abilities would benefit from a safe place to walk and run. Research has shown that activity and socialization are mandatory for a healthy aging population; the benefits of these two things multiply when done together. A track provides a safe and comfortable place for people of all ages to walk and talk and explore and improve fitness.

The town has a gym that houses treadmills, but treadmills do not provide the same benefits that a track does for socialization and accessibility. Nor do treadmills provide the same impact for strengthening bones and improving mental health.

I would be interested in having a further conversation on the idea of an indoor track. Please let me know a time that would allow for this conversation.

Please find the quarterly Community Policing Report attached that covers the April 1st to June 30th, 2023 reporting period. The attached report outlines a quarterly snapshot of the human resources, financial data and crime statistics for the Jasper Detachment.

As part of the Alberta RCMP's ongoing priority to ensure public safety, encouraging citizens to report all crimes plays a vital role in building community well-being. We recognize that nonurgent crimes such as minor thefts and property crime may go unreported due to various reasons such as perceived insignificance or fear of inconvenience. Thus, the Alberta RCMP continues to engage citizens on the importance of reporting non-urgent crimes to help us optimize our crime prevention efforts.

To help facilitate this, we have made reporting of non-urgent crime easier through the Alberta RCMP APP (available as a free download on the <u>Apple App Store</u> or <u>Google Play</u>). Online crime reporting offers a convenient way for citizens to report non-emergent crime to Alberta RCMP from their computer or smartphone without having to phone or visit the police detachment.

An informed community is a safer community. Here are some reasons why online reporting of non-urgent crimes matters:

- Alberta RCMP police officers in the Call Back Unit are responsible for investigating online crime reports, thus reducing the need for frontline police officers to respond. Encouraging the public to use online crime reporting gives the Detachment frontline officers an opportunity to spend more of their time for proactive policing activities in the community.
- Non-urgent online crime reporting also has the potential to reduce those same nonurgent phone calls to our 911 Operators (OCCS) and Detachment Staff.



 The Alberta RCMP encourages citizens to report every crime to allow us to leverage reliable data to identify patterns and trends in criminal activities in our communities. We also use this intelligence to distribute our resources strategically and ensure that our police officers are deployed where they are most needed.

Thank you for your ongoing support and continued guidance in ensuring that we are consistently meeting your community's evolving policing needs. As the Chief of Police for your community, I invite you to contact me should you have any questions or concerns.

Community Priorities

Priority 1	Increase Education/Enforcement to Reduce Driving Complaints
Current Status & Results	In consultation with both Parks Canada Jasper National Park and the Municipality of Jasper Mayor, the concern with respect to Traffic Safety was identified as a unit priority. Education and enforcement was identified as potential avenues to address the ongoing reduction of related calls for service. Same would also hopefully lend to the reduction of fatalities, related injuries and significant property claims stemming from motor vehicle collisions. Each year, Jasper Detachment personnel responds to significant calls for service as it pertains to motor vehicle collisions. The direct correlation is attributed to speeding, driving undue care and attention and increased tourism visitation. Inclement weather conditions during the winter months lends to increased calls for service; however, motorists driving for the road conditions would mitigate some of these unfortunate incidents. Public education via media releases and community engagement would also assist in addressing the reduction in related incidents and calls for service. Jasper RCMP Detachment and Edson Integrated Traffic Unit will continue safety initiatives with the goal of increased policing visibility and public awareness and safety.
Priority 2	Police Visibility
	Both the Municipality of Jasper and Parks Canada Jasper National Park agencies have indicated the need for increased community engagement and Red Serge community engagements in the national park. Policing in this international tourism destination is unique, diverse and center stage for promoting the RCMP and the community in a positive manner. Initiatives requires a significant level of community minded and inter agency consultation to

engagements in the national park. Policing in this international tourism destination is unique, diverse and center stage for promoting the RCMP and the community in a positive manner. Initiatives requires a significant level of community minded and inter agency consultation to facilitate these approaches. Parks Canada JNP continues to forecast increased tourism visitation anticipated for this fiscal year. Both Parks Canada and the MOJ have indicated Red Serge duties are a fantastic mechanism to promote the RCMP and community policing relations in a very positive light. With that being said, the unit have endeavored to excel in this area and have surpassed expectations for this quarter. Members participated in Red Serge duties for the Jasper Pride Festival Flag raising Ceremony, the local high school graduation ceremony, RCMP Musical Ride and the Canada Day ceremonies (K Division Pipes and Drums). The unit received significant positive feedback from the community, including local media coverage and a plethora of appreciation from various community stakeholders. The challenge at the moment is balancing the demand for Red Serge duties with operational demands. The unit will continue to endeavor to meet these obligations and does have the support of "K" Division management moving forward.

That Committee direct Administration to return to a future committee of the whole meeting with a draft Code of Conduct in Municipal Facilities Policy written in plain language for review.

Options:

That committee direct administration to utilize the existing Bylaw #070 and build internal capacity to take action when conduct by the public is in contravention of that bylaw.

Background:

At the March 21, 2023 Regular meeting, Council received the correspondence regarding the Jasper Hockey League conduct for information; and directed Administration to come back to a future Committee meeting with recommendations. Since March, Administration has reviewed what documents (bylaws, policies, procedures) we have internally related to this topic. Then, administration also looked at what other municipalities do to ensure safe, welcoming public spaces.

Currently, the Municipality of Jasper does not have a policy specific to code of conduct within municipal facilities. <u>The Conduct in Public Spaces Bylaw #070</u> outlines expectations for the public's conduct in any public space within the townsite. In that bylaw there are clear expectations about conduct which would apply to the situation Council heard about in March at the Jasper Arena:

*"*3.1 No Person shall, in the Town of Jasper, participate in a fight or other physical confrontation in any Public Place.

3.2 No Person shall, in the Town of Jasper, yell, shout, scream or call out profanities or obscenities in a Public Place or in any place such that such profanities or obscenities can be heard in a Public Place."

To successfully implement the Bylaw, administration created a Jasper Arena Conduct in Public Spaces Policy in 2017 which is a more simplified version of the bylaw that the public can read and understand. That policy is posted within the Jasper Arena and emailed to all facility renters. The policy does go into what is considered unacceptable conduct. It also lists the individuals who have the authority to remove patrons who are acting in such a manner. However, the policy has not been formally reviewed or adopted by Council.

Section D of the Policy Manual covers Facilities and Properties. <u>Policy D-010 Community Use of Municipal</u> <u>Facilities</u> stops short of setting out expectations around behaviour within municipal facilities. After a review of what bylaws and policies are already in place, Administration looked at what other municipalities in have in place to address conduct within facilities. Several municipalities have documents of this nature in place including: Code of Conduct Policies, Facility Guidelines, Conditions of Use etc.

Here is a list of documents administration reviewed in detail:

- Zero Tolerance Corporate Policy, City of Burlington
- Code of Conduct, City of Fort St. John
- Patron Code of Conduct, City of Powell River
- Code of Conduct, City of Burnaby
- Arena Use Guidelines, City of Edmonton
- Code of Conduct, City of Coquitlam

The documents vary in format but drive home a similar point – zero tolerance for inappropriate behaviour within a municipal facility. Each community then takes a unique approach to defining appropriate or inappropriate behaviour.

Discussion:

A key consideration for Council is whether the current documentation is sufficient, or whether Council wishes to see Administration draft more documentation to support appropriate behaviour within municipal facilities. Administration could focus on ensuring staff are aware of their existing authority and duty to uphold Bylaw #070. Administration could also draft a policy specific to code of conduct within municipal facilities for Council's review.

Recommendation:

That Council direct Administration to proceed with the purchase of a new Tractor and implements for winter sidewalk maintenance.

That Council direct Administration to proceed with the purchase of a 10 ton dump truck for snow removal operations.

Alternatives:

- Delaying the purchase of another tractor is feasible, but will delay any enhanced level of service regarding winter sidewalk maintenance.
- The purchase of the 10 ton dump truck could be deferred, but we will continue to incur contractor costs even during small snow fall events.

Background:

The Capital Budget approved for 2023 included 2 items, a loader mounted snow blower used for our winter road clearing and a Snow Cat used for maintaining the snow dump, that Administration was able to purchase for much less than anticipated. The savings on these 2 items are \$103,000.

During budget planning this year, the concept of increasing our level of sidewalk clearing was discussed, and Administration is preparing to present the anticipated cost for the service during the 2024 budget presentations. In order to be able to provide this service there needs to be a secondary crab steer tractor added to the fleet. Quotes for this item are \$80,000 including a hydraulic broom and all necessary implements, and delivery could take place within a few weeks.

Another item that Administration would like to reallocate funds is for the purchase of a 10 ton dump truck to supplement our fleet.

We were successful in hiring experienced qualified Heavy Equipment Operators this year and with this new staffing level there is more work that can be performed in-house. Administration is seeking to delete the purchase of a 4x4 1 ton pickup truck (\$100,000) and the purchase of the ³/₄ ton pickup truck (\$70,000). The funds from these 2 items would be used to purchase an additional 10 ton dump truck not to exceed \$170,000.
